


TASK 1 (5 marks)

LIBRARY OF THINGS

A Library of Things is a collection of items for loan that expands the boundaries of traditionally defined library materials. Objects often include kitchen appliances, tools, gardening equipment and seeds, electronics, toys and games, and musical instruments. Especially appropriate are objects that are only useful occasionally or are difficult to store. Collections vary widely, but go far beyond the books, journals, and media that have been the primary focus of traditional libraries.

The Library of Things supports the "sharing economy" and the city's sustainability efforts, as sharing items means less waste. The collection also offers an opportunity to "try before you buy," to save money, and to test out something you might not have come across otherwise.

The Library of Things collection is funded through the library's materials budget - just like books. Donations of "things" to the Library of Things collection are not accepted.

TRAVELLING WITH PETS**Travelling to Spain from an EU country**

To introduce a dog or cat into Spain, the pet must:

- Be identified with a microchip, or tattoo (if it was done before 03/July/2011 and provided that it remains legible).
 - Be vaccinated against rabies with a valid vaccine at the time of travel and included in the passport.
 - Have a European pet passport. The sections "Owner", "Description of the animal", "Marking", "Issue of the passport" and "Rabies vaccination" must be completed in the passport.
- Dogs and cats under 15 weeks of age, and therefore not vaccinated with a valid rabies vaccine, **are not authorized to enter Spain:**
- The minimum age for vaccination is 12 weeks.
 - For the vaccine to be valid, at least 21 days must go past since the day of vaccination.
